Sanja Filipović is a senior research associate at the Economics Institute and an full professor at the Faculty of Business Economics.

She is engaged at the Economics Institute as a project manager and lectures International finance, Public finance and Globalization of the world economy at the Faculty for Business Economy, Department of Finance.

She was born on April 16, 1976 in Zemun. She received her Ph.D. in 2008 and M.Sc. in 2003 in International economics, from the Faculty of Economics in Belgrade. Her professional interest covers international economics, macroeconomic and sectoral policy, and the field of her narrow specialization is energy sector policy.

She has 18 years of working experience, of which the first four in the real sector of economy and the certain period of services at the Government of the Republic of Serbia. She has been employed at Economics Institute since 2002, at the Centre of Economic Research, and at the Faculty for Business Economy since 2008. As of that year, she has been project manager in the field of analysis and evaluation (macro) economic and sectoral policy, development of institutions and investment environment.

Since 2013, she has been editor of the scientific journal "Industry", a member of the editorial board of the scientific journal "Business Economics" and a reviewer of several scientific journals in the country and abroad. She is member of the International Scientific Advisory Board SDEWES conference supported by UNESCO. She is coordinator of the Working Group on negotiating for Chapter 20 at the National convention on the European Union.

She participated in developing more than 60 projects, of strategic national importance, of which many have been developed for the purpose of the Government of the Republic of Serbia: Serbian post-crisis economic growth and development model 2011-2020; Economic position of industrial branches and 2011-2020 growth projections in the Republic of Serbia; Serbian Strategy of Economic Development 2006–2012; Serbian National Strategy for the Accession of SCG to the EU, Key Economic and Legal Issues for the Successful Functioning of the Commodity Exchange in the Republic of Serbia, etc.

She was engaged in numerous projects whose procuring entities were international institutions, among which are: „Supporting the implementation of the CEFTA agreement“ (EC & OECD), „Competitiveness and New Industrial Policy“ (EC & OECD), „Investment Reform Index in SEE countries“ (OECD), „Administrative Barriers for Investment“ (World Bank), „Improving the process of economic reform legislation in Western Balkan countries“ (OECD, GTZ), „Financial Infrastructure and Financial Market in Serbia“ (GTZ), „Human Development Report“ (UNDP), „Sector study in the field of agriculture and food industry in AP Vojvodina“ (ADA), etc. On several occasions, she was a member of the international team of experts conducting research in the regional countries.

She is a co(author) of 5 monographs and more than 70 scientific papers published in leading journals of national and international importance. She has participated in numerous scientific gatherings and conferences in the country and abroad.
